His career spans more than 28 years of leadership, innovation and advocacy for individuals seeking Social Security disability benefits.

Experience That Transforms Lives

Since 2019, Mr. Leibovic has served as president of And Benefits For All Inc. In this role, he leads a team dedicated to assisting individuals in obtaining Social Security Disability benefits. Known for his personal approach, he has built a successful practice centered on empathy, education and effective representation before the Social Security Administration. "I've helped hundreds of thousands of people in their lives, and when I think about that, that's very humbling," he says.

Before launching his current firm, Mr. Leibovic was the lead attorney for the Federal Benefits Department at Leibovic Law Group LLP, from 1995 to 2016. During that time, he managed a staff of 175 case managers and 18 attorneys, guiding clients through California's complex eligibility procedures. Earlier in his career, he worked with Health Advocates, the state's largest eligibility law firm, where he collaborated with approximately 150 hospitals to help patients access benefits.



Lessons That Inspire Leadership

Mr. Leibovic's passion for helping at-risk and underserved populations stems from his early experiences growing up in Los Angeles. As a young man, he was part of the Sunset Strip heavy metal scene. "I didn't excel in school," he says. "And I think it's a lesson to everyone that you'd be surprised how you can change your life through hard work, with the right role models and a healthy support group."

Outside of his legal practice, Mr. Leibovic founded two nonprofit organizations in California that provide advocacy and counseling for At-Risk Youth and their families. He also serves as an ordained Rabbi in three congregations and continues community outreach with speaking engagements, training sessions and charitable contributions.

Disability Education Through Media

In addition to leading his firm, Mr. Leibovic has become a recognized educator and advocate in disability law. His presence on social media, particularly TikTok, has brought disability law education to a broad audience. With over 725,000 followers and around 70 million views, his short instructional videos have become a trusted resource for individuals navigating the benefits process.

In 2023, Mr. Leibovic published "101 Tips to Win Your Social Security Disability Claim." The book was featured in a Times Square billboard campaign and he hopes it will earn a place on The New York Times bestseller list. He also has plans for a second book and intends to explore creative community engagement concepts, such as disability-themed pop-up shops.

Awards and Recognition in Public Service

Mr. Leibovic's professional achievements have earned national attention. In 2016, he was featured on the cover of the Jewish Journal as California's top Mensch and was named among Los Angeles' top 10 Mensches. He also received commendations from the U.S. Senate, the U.S. House of Representatives, the California State Assembly and several Los Angeles government agencies. His firm has also received honors from the New World Report and Corporate LiveWire, including Legal Elite Awards and the Disability Advocacy Firm of the Year distinction.

Al Technology with a Human Touch

Always seeking new ways to improve client service, Mr. Leibovic has developed an artificial intelligence-powered platform to assist users with disability eligibility screening. His new Attorney Avi App allows individuals to describe their conditions verbally and receive guidance, which he personally reviews to maintain accuracy and compassion.

Reflecting on his career, Mr. Leibovic attributes his success to his wife, Rena, and his parents, Al and Barbara. "You can't go into this field just to make money," he says. "You really have to



be dedicated and committed to helping others." He continues to work late into the night, answering emails and developing tools for outreach. As a result, he gives hope to clients who struggle and feel alone.
